JURY RECOMMENDATIONS RECOMMANDATIONS DU JURY

1. It is recommended that the Niagara Regional Police Service study, review and consider updating General Order 167.03 with respect to assessing its' currency in accordance with the latest knowledge and best practices on how to effectively deal with the vulnerabilities of Emotionally Disturbed Persons and those who may be experiencing Excited Delirium.
2. It is recommended that the Niagara Regional Police Service transfer the administration and delivery of the Crisis Intervention Training (CIT) Course to the Training Unit for the purposes of prioritizing delivery of the CIT Course to officers assigned to Uniform Patrol Duties and those assigned as coach officers and front line supervisors.
3. It is recommended that the Niagara Regional Police Service review the content of the Crisis Intervention Training (CIT) Course for the purposes of providing components of the CIT Course to all front line officers on crisis de-escalation techniques during the annual In-Service Training cycle.
4. It is recommended that the Niagara Regional Police Service should amend General Order 167.03 to provide that when an Officer becomes aware that they are involved with an Emotionally Disturbed Person who may present a risk of harm to themselves or others, notify the dispatcher as soon as possible in order that the dispatcher immediately inform a Supervisor.
5. It is recommended that the Ministry of Health and Long - Term Care of Ontario and Health and Welfare Canada study, review and consider updating their policies and currency of the latest knowledge in relation to the education of the public on Excited Delirium.
